separated, and receiving no child support. They need clothing, shoes and money for bills. We gave them a \$250 WalMart card.

Teresa is a single mother of 5 children, receiving no help from her ex-husband. She has a job in a clerical position, but she struggles for anything but bare necessities. We gave her a gift card to Wal-Mart for \$250.
