

Who: The Whole Family!



General Aid Recipients



yanna Chavez—a single mother of two, whose son was diagnosed with cancer, compromising his lymphatic system, which makes him regularly sick. His medications have become expensive, and because Tyanna works full time, she does not qualify for food stamps. She was grateful for the WalMart gift card for \$299.

imothy & Jennifer Varela—a couple with four children, Jennifer was recently diagnosed with Lupus. They have spent all their savings and some monthly income on medical expenses, and are now short on rent, with no money for clothes or school



supplies. We gave them a gift card to WalMart for \$299.



ichelle Alarid—is a mother of two, and her daughter has just had a baby. Her monthly expenses currently exceed her salary, and she is looking for additional

work to cover the difference. She needs help fixing her refrigerator/freezer, as well as school clothes for her son. We gave her a \$300 WalMart gift card.

Ilen Atencio—is a women whose sons live with her, one just left the military and lives there with his girlfriend and infant daughter, and the other is 12-years old. She has been diagnosed with cancer and has been undergoing treatments, which will include radiation beginning in October. Her only vehicle was in an accident, and she must travel from Espanola to Santa Fe every day for her treatments, lasting 6 weeks; so she must find and pay for that daily transportation. To help her out with , we wrote a check to Adobe Propane for \$300.00.

ilbert Felix Vasquez—is a severely disabled individual, whose family is struggling with the medical costs for his Sarcoidosis with Fibrosis. They are unemployed, as he is disabled and she is taking care of the home and children. He's taking steroids, whose long-term use is detrimental. An alternative treatment is available in Denver, CO, which is a last resort before a lung transplant is needed. They want refrigerated air to ease the strain on his lungs, or help with travel costs to Denver. We gave them \$300 to WalMart to help with regular expenses.



atalie Gutierrez—is a mother of three, with another on-the-way, is unemployed due to injury. Her unemployment ended in April, and her fiancé is also injured and unable to work. The unborn baby was diagnosed with spina bifida, and Natalie underwent prenatal surgery on the

baby. The cost of this surgery plus travel overwhelmed the family, and they have great need for any financial help available. We paid their PNM and Gas Co bills.

shley Ruiz-Farmer—is a high school student on the all-star cheer team, Fifth Dimension, who competes around the country. She volunteered at the last LODLF event, and is now asking for help with travel and competition fees. We gave a



check to Fifth Dimension for \$200 on her behalf.

asmine Watrin—is a single mother of 3, currently unemployed, whose only income is unemployment. Her daughter was diagnosed with aplastic anemia, requiring chemotherapy and a bone marrow transplant. Because of the treatment, they were forced out of their apartment. We wrote a check to that complex for \$300.00

uis Ordonez—is a student at Albuquerque High School, and one of the presidents of their DECA chapter. He is asking for help with her trip to the Leadership Conference, as his single mother, who cares for him and 3 other children, cannot afford the cost. We wrote a check to AHS DECA for \$100 on his behalf.

athryn Angela Chavez—is a woman on social security disability who adopted her grandson, now 14 years old. SSD is her only source of income, and she does not yet qualify for Medicaid. She is moving into community housing because she cannot afford her current rent. She asked for help with school clothes and supplies for her grandson. We gave her a \$200 WalMart gift card.

upe & Andrea Baca—are a couple with a new baby, living in a trailer, after being without a home for awhile. His shoulder injury has made it difficult to find regular employment. They need help with water bill, as well as repairs for the car. We wrote a check for \$150 for their water bill, and gave them a \$150 gift card to WalMart.

aylor Novak—is a middle-school student at Desert Ridge. A straight-A student, she is involved in student council and book clubs, and she is a level 7 gymnast at Gold Cup Gymnastics. She needs help with her competition costs, which are up-

wards of \$2,500, including fees, travel, costume, tuition. We gave \$200 to Gold Cup.

amien Prieto—is a single father of a teenage girl, Lila, who has a cancerous tumor in her brain. Damien has been unable to return to work, due to Lila's constant sickness and regular extended hospital stays. Because of this, he is under considerable financial strain. We wrote a check to NationStar Mortgage for \$299.



HS DECA—is an organization that has participated in multiple events for LODLF, giving their time, money, resources, to help make the charity a success. For years, they've volunteered with the NM Army Corps of Engineers for National Public Lands Day. They need help with the cost of a bus to transport the students to volunteer. We were happy to donate \$200 to the group.

imberly Castillo—is a student at Albuquerque High School, and one of the presidents of their DECA chapter. She is asking for help with her trip to the Leadership Conference, as her mother cannot afford the cost of the trip. She has volunteered at LODLF events, and is active in her community. We wrote a check to AHS DECA for \$100 on her behalf.

abrina Howe—is a student at Cleveland Middle School, wanting to attend the annual Social Studies trip to DC, which costs \$2,099. Her mother, Trula, volunteers with LODLF, but cannot afford the trip without help. They are working on fundraisers with family, church and friends. We wrote a check to World Strides for \$250 for down
